It is a global model.

We've made visible impact and inroads into improving the conditions at Animal Shanties, embodiments of appalling cruelty. Public, government and farmers are listening, and learning from our actions.

Lowering Dog and Cat menace cases, successfully introduced A.B.C in many communities; thereby, curbing Wildlife Crimes. Legislatively, we are working towards better treatment of pedigreed dogs and elimination of abhorrent puppy mills.

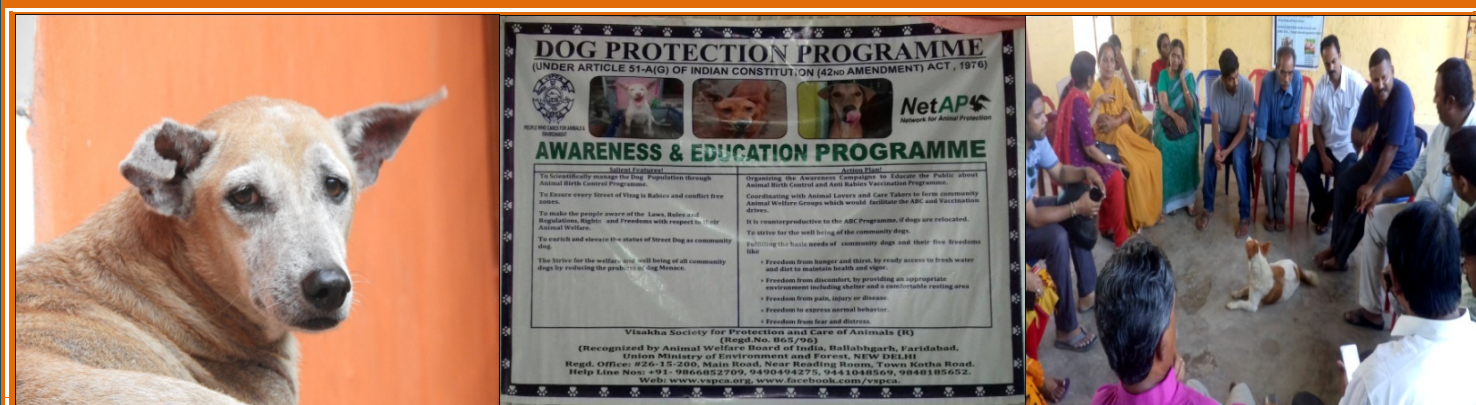

Spay/Neuter/Immunization - A. B. C./A. R. V.



Scientific, comprehensive and humane ways to mitigate street animal-human Conflicts is to spay/neuter and immunize street Animals. This enables effective management of dog and cat populations in the community.

VSPCA *pioneered* Animal Birth Control (A. B. C.) in Visakhapatnam and to-date has performed surgeries on 70% of the dog population in Visakhapatnam's Urban and Rural jurisdictions.

The A. B. C. policy is the reason for City officials to refrain from unnecessary and ruthless culling of dogs and cats in Visakhapatnam.

Immunization of street animals is key to circumventing casualties and/or hostility towards non-human animals. VSPCA believes this to be a win-win situation for animals and humans. It is an effective tool in developing compassionate coexistence.

Rigorous Spay/Neuter/Immunization practices with adherence to strict protocol and "asepsis" procedures, has resulted in *zero* Rabies casualties in Visakhapatnam since twenty-five (25) years.

Cat Protection Program - C. P. P.



VSPCA implemented and operates a comprehensive Protection Program for Feral/Street Cats in Visakhapatnam, which is all-rounded ensuring coverage of all aspects of cat welfare. Key strategies of this program are:

Awareness: Engaging, campaigning and interacting with communities, lowering hostility and irrational killing of cats, and demonstrating active ways of combating menace, while exhibiting peaceful co-existence.

Cattle Respect Program India: CRPI



CRPI is a keystone initiative of VSPCA, which undertakes the welfare and well-being of Cattle and/or Livestock by restricting illegal bovine transportation, exposing illegal slaughter, and working through authorities via lobbying, collaboration and awareness planning and implementation. The Strategies are:

Humane Management of Animals in Animal Shanties: Working with various government agencies and village panchayats to develop humane facilities for animals brought into shanties. Curbing illegal auctioning and illegal transportation activity in the animal market premises.

No. of Animal Shanties Campaigned in 2018-19: **27**

Awareness (including, of Veganism and the Global Vegan Movement) in Markets: Campaigning for humane ways of loading/unloading animals, rules and laws pertinent to farmers, transporters and market laborers.

Simhachalam Calves Protection



Simhachalam Calves issue is a deep well of sorrow for calves abandoned at the steps of Simhachalam Temple, as 'God-appeasing donations.' This is nothing but pure naivete, and in the guise of abandonment, neglect, smuggling and slaughter. Humans are brain-washed into believing they venerate at God's feet, while they actually discard the trusting calves.

VSPCA'S battle for the calves is decades old. We will not give in or give up! We continue fighting for respect for these babies/calves, their humane treatment, spreading awareness to devotees so as to not offer calves as mere tributes, and importantly, working with concerned government domains for the well-being of the abandoned innocent calves.

After an assault on VSPCA activists in Spring 2019, who protested against the illegal transportation of calves by Temple Authorities, our Founder and team pressurized Government to form a Tri-Member Committee comprising of VSPCA, The Animal Husbandry Department and the Simhachalam Temple Authority for Protection and Well-Being of the Calves. This has greatly reduced the number of discarded calves by 75% with a pathway now/solutions to manage these calves in "cooperatives" with the help of farmers in and along border of Andhra and Orissa states.

Olive Ridley Turtle Protection



It has been 23 years conserving Endangered Olive Ridley Turtles who consistently, have laid eggs along Visakhapatnam's Coast. This year witnessed record achievement - 89% of the eggs successfully hatched into healthy baby turtles and were released at sea. In 1996, 23 nests were identified at R.K. Beach. This number is at 785-Turtle season 2019. We are grateful to Collaborators, the Andhra Pradesh Forest Department and National Thermal Power Corporation (NTPC)-Simhadri.

Wildlife Protection



Nestled between the mighty Eastern Ghats and the pacific Bay of Bengal, Visakhapatnam is blessed with spectacular wildlife. However, in a rapidly-transforming urban-scape, rife with deforestation and poaching, the wildlife here is struggling to live. Human sprawl and other human-induced activity is forcing several species of wild animals, birds and reptiles out of forests and into human habitation, increasing their already-vulnerable condition towards casualties. Primates, big cats like leopards, wild boar, magnificent bird predators of many varieties, and several species of reptiles are threatened by human activity.

Sadly, as in other forests of the world, increasing demand for 'Bush Meat' is treacherously wiping out the last remaining wildlife in Visakhapatnam. VSPCA has implemented thoughtful and incremental wildlife rescues and worked at rehabilitation and release since 1996. It continues its vigilance and monitoring limiting several notorious Wildlife Poaching Rackets in the city.

Wildlife Liberation



Apart from protecting wildlife in natural habitats, VSPCA has undertaken liberating wildlife from human captivity. This is akin to the sad story of the Simhachalam calves in human hands. Similarly, wildlife in human captivity is about exploitation and breaking of the animal spirit for human survival. Both, the human and the animal in captivity are vulnerable; however, the human is in control and can be very cruel to the animal.

This issue is unique to Southeast Asia. VSPCA has been tackling this issue over the years, which has successfully resulted in eradicating Snake Charmers at temples and snake habitats, and, “Parrot Astrologers” and “Monkey Performers” at several tourist destinations. We continue rescuing several wild animals from Kalandhars (“Saints”), Astrologers and Snake Charmers every year. Our rescue efforts have resulted in the liberation of several birds, snakes, monkeys and other animals as well as guiding communities who dwell in wild places.

One-Stop Feeding Stations-The Foundation Project



Prior to the VSPCA's official formation, founder-Pradeep Kumar Nath pioneered a systematic effort to benefit starving animals. This program is unique to VSPCA. It continues on steadfastly, feeding hundreds of street animals, many on the brink of starvation.

Implementing this passion in an organized way, the beneficiaries of VSPCA's feeding stations have increased by the hundreds.

This effort streamlined into evolving other resources (within other animal-welfare initiatives) benefitting thousands of animals in the City. The provision of water bowls for dogs and cats now available throughout the City was borne out of this project's understanding.

This heart-borne initiative also happens to be the basis of vegan meals for starving homeless persons with companion animals.

Quenching the Thirst



“Quenching the Thirst” is a noble project initiated to quench the thirst of a starving animal.

Since the initiative was implemented, there have been hundreds of water bowls set up, benefitting scores of animals/large-and-small-mammals, critters, reptiles and birds/pollinators. This really matters in the extremely hot climate of Visakhapatnam during summers. We have concentrated on arid industrial areas where animals don’t have access to water to quench their thirst. Establishing freshly-filled water bowls at these sites through the municipal water authorities, has helped the animals thrive. Additionally, this is observed to reduce human-animal conflict.

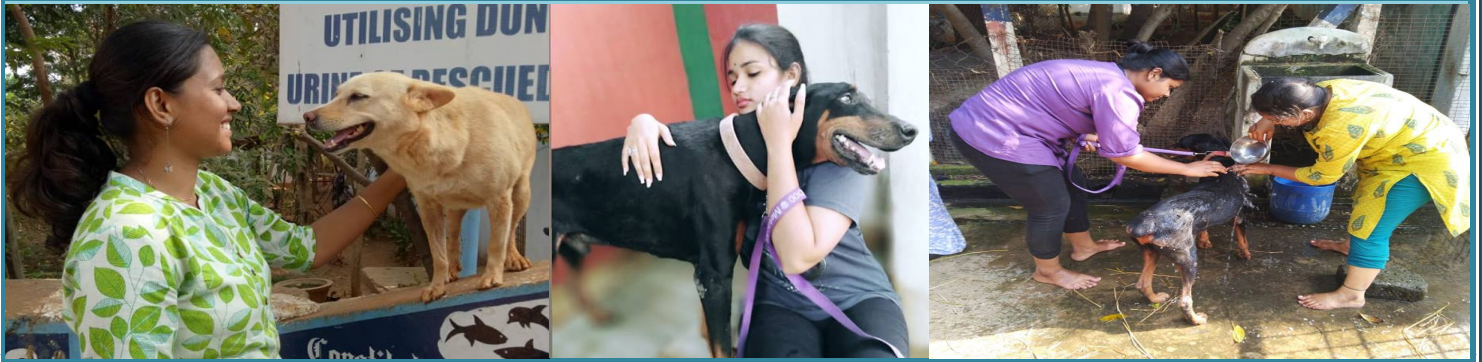

Inspiring Youth about Animal Welfare

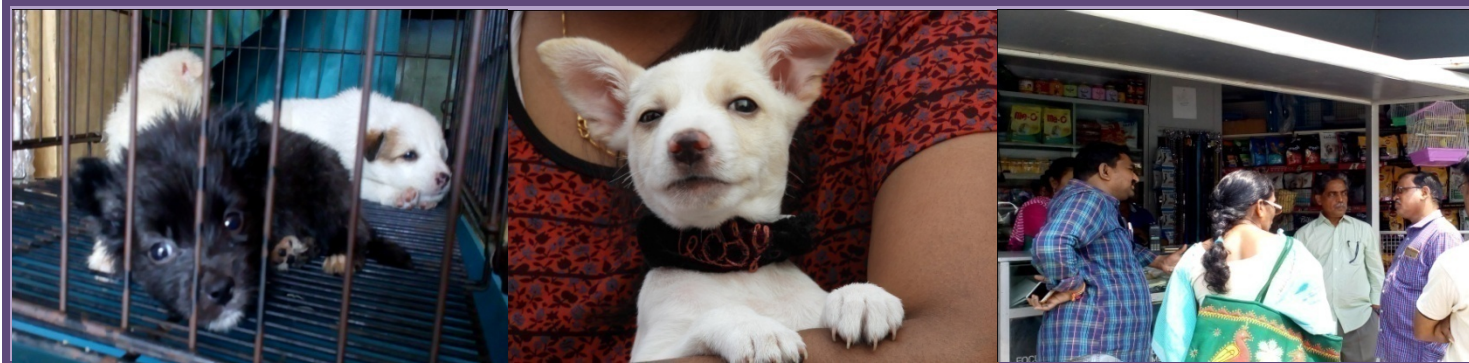

To this end, we collaborated with [Gitam School of Gandhian Studies](#), a University-in-the-making, focused on the Animal Rights, Environmental Conservation and Justice Movements. We involved thirty-seven (37) students from various academic backgrounds providing opportunity to work with VSPCA on different projects. Every youngster participated with great enthusiasm with VSPCA serving Animals and the Environment. We will continue to demonstrate compassion in action.

Pedigree Dog Rescue-Rehabilitation



VSPCA is fighting strongly against the inherent cruelty within normalized practices and unethical breeding of pedigreed dogs, their sale and marketing. VSPCA rescues, rehabilitates and facilitates adoptions for pedigrees. We are working with the various Government Officials to regulate by policy and by law, the illegal breeding, sale and marketing of pedigreed dogs.

Pedigreed dogs are the output of an unholy industry of puppy mills. The face of the industry is a beautiful puppy, touted as 'human's best friend,' evoking feelings of love and ownership in humans wanting to possess these beautiful dogs. However, breeders thrive making huge sums from innocent animals, keeping them in sordid conditions. The female dog is continually exploited as are her puppies. Dog breeding areas are not in the public eye. People buying the animals are enraptured by the pedigreed puppy.

VSPCA organizes drives for the adoption of shelter animals and promotes and advocates acceptance of street animals.

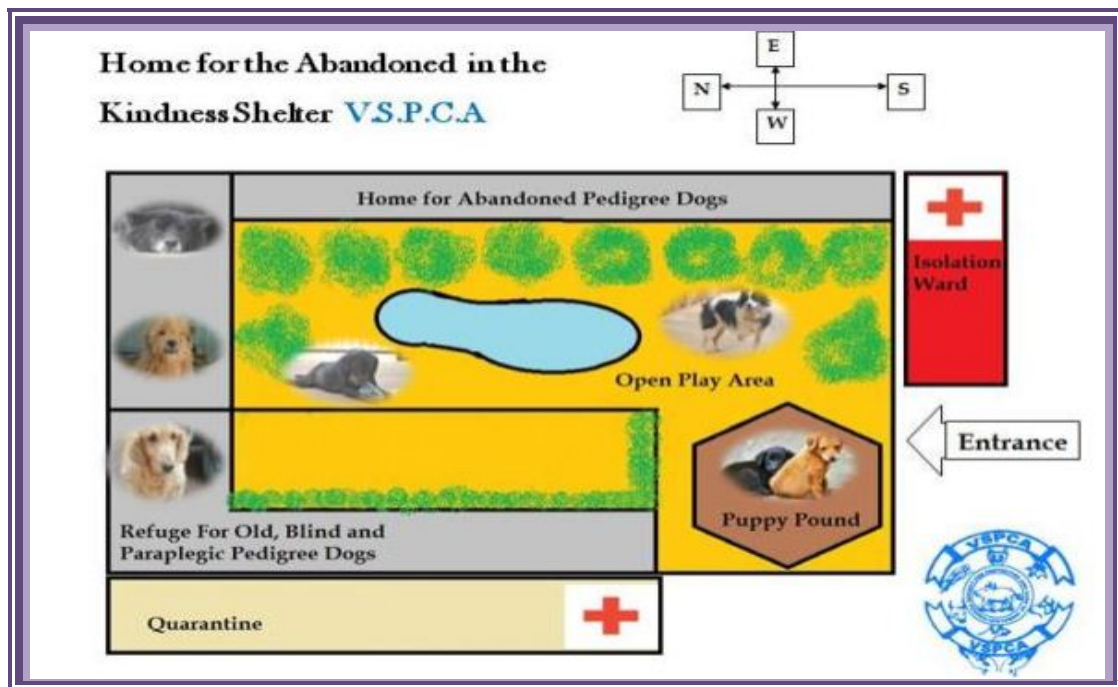

Refuge for Pedigree Dogs



Currently we are raising funds to develop a Pedigree Dog Rescue-Rehabilitation- and Transit- facility at our Kindness Farm. This facility accommodates about One Hundred and Fifty (150) Dogs which cannot survive on their own upon abandonment.



VSPCA's Distinctive Achievements

Year 2018-2019

Apart from Animal Welfare Advocacy, VSPCA has implemented just and innovative solutions to complex issues relating to animals and the environment. VSPCA has pioneered a Community-Based-Service approach, executing real-time scalable solutions involving governing authorities collaborating with several teams, to resolve complex problems.

We have successfully paved the way for annual dog sterilization and immunization, which has resolved conflict and avoided disease contraction. Working with Government's Animal Husbandry, Revenue, Road Transport and Police Departments on infrastructural changes and enforcing the law in Animal Markets; has reigned-in on illegal cattle smuggling sending a clear message to cattle mafia. Protecting Sea Turtles in collaboration with NTPC and Andhra Pradesh Forest Department is a win in the fight against Climate Change and for the public of Visakhapatnam. It has put many locals on the path to thinking about the Climate Crisis. Cooperating and collaborating with different Government Departments ensures a comprehensive Animal Welfare approach benefitting hundreds of Animals.

- VSPCA is the trainer for the Local Governing Bodies of Mumbai, Navi Mumbai and CIDCO. The training agenda includes - Humane handling of dogs i.e. Butterfly Net Catching Technique, Stringent Asepsis Methods, etc. VSPCA is providing additional consulting and comprehensive training on Animal Birth Control for the Brihan Mumbai Municipality.
- VSPCA in collaboration with Sweden's Veterinarian team – [AWAKE](#), has provided training to over 40 veterinarians from the Animal Husbandry Department regarding sterilization of dogs and cats.
- Agencies from neighboring cities are consulting with VSPCA for comprehensive training on a Sterilization Curriculum for dogs.

VSPCA's Distinctive Achievements

Year 2018-2019

- VSPCA won the bid as consultant for Mitigation of Human-Primate Conflict for the state of Andhra Pradesh. We are advisors to Andhra Pradesh Forest Department.
- Founder Mr. Pradeep Kumar Nath, is selected as a Master Trainer by the Central Ministry of Home Affairs under the [Student Police Cadet](#) initiative to demonstrate the subjects of [Sympathy, Environmental Education and Compassion](#).
- [23 Years of Olive Ridley Protection](#) - a record 785 Nests with an 89% success rate, implies that this 2019, has witnessed the greatest number of baby Sea Turtles from Andhra having made their journey safely into the Bay of Bengal.
- Collaboration with [Gitam School of Gandhian Studies](#) for engaging youth in the Animal Welfare Movement.
- Collaboration with the Taj Group of hotels – Vizag: Educating ground level staff and the dining wing to avoid using Glue Traps, which trap rodents and raptors cruelly until an agonizing death. Teaching staff about humane ways of deterring critters. Broaching the subject of Veganism as a healthy and sustainable lifestyle.
- Collaborated with the Urban Governing Body of Visakhapatnam on undertaking crucial initiatives to further safeguard the community dogs to eliminate canine-human conflicts.

Natural Calamities

Cyclone Phani:

Visakhapatnam is iconic as a coastal town with its peaceful beaches and “smart” settlements. Ironically, this beautiful city bears a toll under Mother Nature’s destruct and regenerate phenomenon. This coast is at high risk with cyclones and depressions. Each year several cyclones hit Visakhapatnam and its neighbors wreaking havoc on natural places and humankind. Gusting winds and heavy rains flood low-lying areas flushing debris and more into the ocean. There is a high occurrence of casualties when the cyclones turn into super cyclones causing colossal damage. Some such severe cyclones were Hud-Hud, Phyllin and Phani.

On 2nd May 2019, a devastating landfall of the eye of Cyclone Phani Cyclone in the coastal city of Puri in southern Orissa. With wind speeds exceeding 250 km/hour and heavy rains and gusting winds, Phani severely damaged public property worth \$1.3 billion. In the ensuing destruction, VSPCA shelters were cut off from commute, badly affected with damage to certain enclosures and housing facilities, and, heavy flooding drenched and soaked our shelters and new farm plots. Though no casualties occurred, major repairs must be undertaken as early as possible.

VSPCA’s Shelter Managers and the locals were paid to stay on-site for 4 whole days (24x7) through the Cyclone’s onslaught, in order to ensure that all shelter animals were inside buildings or moved to higher areas for their safety, through the storm. This high-level care resulted in only structural damages to enclosures and housing facilities from falling trees and floods but prevented human and nonhuman casualties. The flooding caused great financial damage to our crop harvest and fruit production work.

Mitigation Strategies:

- Shifted the animals to safer and higher places.
- Avoided flooding of shelter by our newly renovated drainage systems.
- Retrofitted our buildings to withstand strong rains and winds.
- Repairs to be taken up as soon as possible.



Natural Calamities

Extreme Heat Waves:

Due to the rising global temperatures, summer has been fiery and smoky with record high temperature levels. This is severely exhausting the living – human and nonhuman. Unpredictable powerful monsoons followed by drought, is making life inhospitable in the region. Scarcity of water and lack of perennial water is adding thirst to injury. VSPCA is being as proactive as can be under the conditions. We are doing everything we can to make life bearable for our animals and employees. Employees are suffering vomiting bouts working in the extreme heat of the animal shanties and slaughterhouses. VSPCA is also working very hard to mitigate the casualties extending funds and physical effort for animals in distress.

Activities in progress

To avoid loss of life at our shelters:

Hydrating all animals and ensuring they have fresh cold water at all times.

Bathing animals and hosing the grounds; taking personalized care to relieve animal stress levels.

Making the enclosures and housing facilities cooler by placing wet mats and providing glucose in drinking water.

Ensuring our Animal Helpers are comfortable being at work. We have changed work timings for those unable to bear the hot afternoons.

To avoid loss of life on field:

Providing water facility in the exposed places.

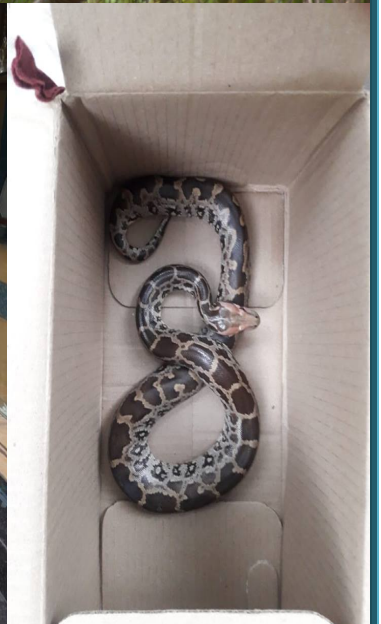
